

WARNINGS AND CAUTIONS

CAUTION

- Keep the cords away from high temperatures or other heat sources.




Tools Required for Assembly: Phillips screwdriver (not included).

ASSEMBLY INSTRUCTION

- Loosen four screws on the back cover of the battery container, and then pull the PVC slice in the direction of the "open" arrow. Re-tighten the screws completely. (Fig.1)
- 2. Place the product onto the water with the solar panel facing upwards. (Fig.2)
- 3. The LED lights within the lily pads will illuminate once there is the sufficient light around the product. (Fig.3)


CARE AND MAINTENANCE

- Clean the product periodically to prevent mineral deposits and contamination. Use soap with a cloth for heavily stained surfaces. Clean the solar lily pads with water. Do not use harsh chemicals as this will damage the finished surface and void the warranty.
- 2. When not in use, remove the product from the water and keep it dry. Open the back cover and inspect the battery container for any moisture to avoid the damaging the product due to battery corrosion.
- 3. Replace the rechargeable battery if you notice a performance reduction in product.
- 4. Each Peaktop product may have variations in texture, finish and appearance from one unit to the next. This enhances the beauty of the product and makes your Peaktop product uniquely individual. Some products and finishes are intentionally weathered or work in appearance for aesthetic design.
